GROUND RULES AND REGULATIONS

1. The spectator may be entered to the location of the sports event if:
 - he has a valid admission-ticket or other certificate to enter,
 - he undertakes to prove his identity at the organizer's request,
 - he is definitely not under the influence of alcohol, drugs or other narcotic agents,
 - he does not have alcoholic drinks, drugs or other objects with him, which endanger holding the sports event, further other people's personal and assets safety, the possession thereof is prohibited by law and carrying them to the sports event has been forbidden by the organizer,
 - he does not have captions, flags or absolutistic symbols prohibited by law exciting hatred toward others,
 - he is not under the effect of prohibition or expulsion,
 - he agrees that his clothes and baggage shall be examined,
 - he acknowledges that during the sports event image and sound record of him can be made,
 - he acknowledges that during the sports event the organizers constantly check the observance of the provisions set in the Ground rules and regulations.
2. The participant may only enter the territory of the sports facility, approach his sector and take the seat given on the admission-ticket through the entrance gate given on the admission-ticket, season ticket. The sports hall – in case the arranger and the organizer do not stipulate otherwise – may only be left through the entrance point given on the ticket.
3. If one enters the area closed to the spectators or a certain group of spectators or throws anything to that area, he commits a crime.
4. The policeman providing security of the event and the organizer are entitled to examine the participant's clothes and package.
5. On the fire routes (corridors, entrances, stairs, exits, entrance points) of the sports facility it is forbidden to stop or to block. It is forbidden to clamber up or to climb any pieces.
6. At the sports event the spectator:
 - is bound to observe the provisions of the Ground rules and regulations and the stipulations set by the arranger,
 - may not have with him or may not consume any alcohol on the territory of the sports facility,
 - may not pursue an activity which might disturb, frustrate the order of the sports event or endanger the participants' personal or assets safety,
 - may not behave in a racist or malignant manner,
 - is bound to leave the location of the sports event at the end of the sports event or at the arranger, the organizer or the police's call due to the evolvement of a situation endangering personal and assets safety.
7. If the provisions set in the Ground rules and regulations are not observed by the spectator:
 - at the organizer's request he does not stop wrong conduct, the organizer shall remove him from the sports event,
 - he does not observe the stipulations regarding safety and leaving the location, he commits an offence, if he behaves violently against the organizer's measures, he commits a crime,

- the organizer warns the person to be removed to prove his identity, if the trouble-maker person does not observe the warning, the organizer informs the police without delay for the sake of identity check,
 - until the police arrives or the end of the third hour after the warning the organizer may withhold the person to be removed, record the action with an image recording device,
 - for the damage arising due to violation of the Ground rules and regulations the spectator, in case of several wrongdoers the spectators participating in wrongdoing, are jointly and severally responsible in accordance with the general rules of the Civil Code on compensation,
 - the wrongdoer is obliged to reimburse all expenses arisen due to wrongdoing to the sports organization.
8. In order to arrange the sports events safely the arranger:
- informs about the objects forbidden to be carried to the sports facility in an announcement,
 - sees to the recorded taking over, keeping safe of the objects that may not be entered but are legally possessed and returning them to the eligible person on leave,
 - if the owner of the objects taken over for safe-keeping does not show up within two hours after the end of the sports event , the arranger or the organizer proceeds in accordance with the rules of responsible safe-keeping,
 - is entitled to observe the location of the sports event, at the entrance point, in the public place belonging to the sports facility and in the assigned parking-lots with cameras allowing single identification of the participants, to take record and to manage them in accordance with the stipulations of the law,
 - has effected a liability insurance for the participants.
9. In order to provide safe departure, the police may withhold a certain group of spectators in the sports facility.
